Applications are invited from the Scheduled Castes Students of Haryana pursuing AICTE approved Courses i.e. Polytechnic D-Pharmacy, B-Pharmacy/M.E./M.Tech/ Ph.D. in Engineering Subjects/MBA/MCA (Through Regular Mode only in Govt./Private/Aided Technical Institutions Approved by Technical Education Department, Haryana) under Scheduled Castes Sub-Plan (SCSP) Schemes of State Government for the Session 2020-21. (i) <b>Tuition Fee Reimbursement:</b> All Schedule Castes Students having Annual Parental income Between Rs. 2.5 lac to Rs.3.5 lac and admitted through centralized counseling are eligible. (ii) <b>Transport Facility:</b> All Schedule Castes Students (Except Schedule Castes Students Residing in Campus Hostel) pursuing study in AICTE Approved Courses i.e. Diploma/UG /PG Technical Courses are eligible.	Tuition fee only (Actual Tuition fee or Rs. 20000/- for Diploma & Rs. 40000/- for Degree Courses whichever is lower); Actual Amount of State Transport Facilities (Train Pass/Bus Pass).

- **AVAILABILITY OF FORM:** Application Form can be down-loaded from the Department website and can also be obtained Free of Cost from the Concerned Institutes/ Universities.
- **LAST DATE OF SUBMISSION BY THE STUDENTS:** The complete filled-up Application Form with all the reputed Documents should be submitted with the Concerned Institutions by 20<sup>th</sup> January, 2021. Application received after due date will not be entertained.
- **LAST DATE FOR TECHNICAL INSTITUTIONS TO FORWARD APPLICATIONS:** All the Heads of the Technical institutions are requested to submit the Consolidated List along with the complete filled-up Application Form and Supported Documents on or before 22.01.2021 to their Processing Centers. The processing centers are requested to submit the Consolidated List along with the complete Application Form and Supported Documents on or before 27.01.2021 to the Disbursing Centre i.e. Govt. Polytechnic, Hisar (Designated by the Department) in case of Reimbursement of State Transport Facilities, Train Pass/Bus Pass and to Disbursing Center i.e. GBN Govt. Polytechnic, Nilokheri (Designated by the Department) in case of Reimbursement of fee.
